The iLEAP International Fellowship is a long-term investment in community-based leadership in Asia, Africa and Latin America. Each year, iLEAP selects up to 15 grass-roots leaders from around the world from a highly competitive pool of hundreds to join this unique, cross-cultural and global leadership training in Seattle. The eight week program is well-integrated, with a balance between personal reflection and retreat, group learning and dialogue, and professional training in partnership, communication, and effective leadership. iLEAP Fellows return home to lead their communities with a renewed clarity and commitment to who they are, what they do, and how together we can change the world. iLEAP staff leadership also organized a gathering in El Salvador for all International Fellowship graduates from Latin America to promote cross-learning and evaluate the impact of the training program. The results were significant increases in leadership qualities, especially in confidence and collaboration, leading to greater effectiveness.

The Social Innovation Forum JAPAN (SIFJ) is a two week intensive training in personal leadership and global partnership focused on working with leaders from specific regions. The Social Innovation Forum JAPAN was created in the wake of the March 11, 2011 Tohoku earthquake and tsunami. SIFJ is an investment in rebuilding the country through energizing civil society, empowering emerging leaders, and forging global partnerships of mutual support between American and Japanese civil society. In 2012 iLEAP conducted SIFJ programs in February and May for a total of 20 delegates from Japan.

Social Innovation in Seattle (SIIS) is a 4 week educational program designed to introduce participants to the idea of social innovation and inspire greater clarity around one's personal leadership and vocation. The integrated curriculum balances classroom learning with a professional internship and different site visits to Seattle-based businesses and organizations pursuing some degree of social innovation. SIIS participants also take part in individual advising and coaching sessions which serve to weave the experience together and make it uniquely relevant to his or her life. In 2012 iLEAP staff leadership worked with SIIS graduates in Japan to convene gatherings of young Japanese and promote dialogue. iLEAP welcomed 40 SIIS participants to Seattle on programs in February and August.
