The iLEAP International Fellowship is a long-term investment in community-based leadership in Asia, Africa and Latin America. Each year, iLEAP selects up to 15 grass-roots leaders from around the world from a highly competitive pool of hundreds to join this unique, cross-cultural and global leadership training in Seattle. The eight week program is highly integrated, with a balance between personal reflection and retreat, group learning and dialogue, and professional training in partnership, communication, and effective leadership. iLEAP Fellows return home to lead their communities with a renewed clarity and commitment to who they are, what they do, and how together we can change the world. In 2013 we trained 14 Fellows in the program that ran from September 30, 2013 to November 22, 2013. These fellows came from South Africa, India, Guatemala, El Salvador, Burma, Rwanda, Indonesia, Honduras, Bolivia, and Cameroon.

The iLEAP Social Innovation Forum:Japan (SIFJ) was created to serve the post March 11th rebuilding efforts in Japan and to amplify the local impact and global voice of those Japanese leading social change efforts in the wake of the triple disaster. The SIFJ is grounded in three anchor points: one, as a capacity building and global leadership training for Japanese social leaders and entrepreneurs, two, as a platform for Americans to learn from and build practical partnerships of mutual support with Japanese civil society institutions and social businesses, and, three, to seed and cultivate new global collaborations within civil society in the Asia-Pacific region in order to best solve key global issues. From 2011-2014 the SIFJ will train over forty key Japanese social leaders and entrepreneurs in the skills necessary to resource their initiatives, grow global partnerships with American collaborators, cultivate the next generation of young Japanese social entrepreneurs, and ultimately, strengthen and transform the civil society sector in Japan. In 2013 iLEAP conducted SIFJ programs in January for a total of 12 delegates from Japan. iLEAP staff leadership also organized a gathering in Japan for SIFJ graduates to promote cross-learning and evaluate the impact of the training program. The results were significant increases in leadership qualities, especially in confidence and collaboration, leading to greater effectiveness.

Social Innovation in Seattle (SIIS) is a four week educational program designed to introduce participants to the idea of social innovation and inspire greater clarity in their personal leadership and future path. The integrated curriculum balances classroom learning with a professional internship and different site visits to Seattle-based businesses and organizations pursuing some degree of social innovation. SIIS participants also take part in individual advising and coaching sessions which serve to weave the experience together and make it uniquely relevant to his or her life. In 2013 iLEAP staff leadership worked with SIIS graduates in Japan to convene gatherings of young Japanese and promote dialogue. iLEAP welcomed 40 SIIS participants to Seattle for programs in February and August.
