iLEAP Global Programs consist of our International Fellowship, Southeast Asia Leadership Initiative (SALI), and Latin American Leadership Initiative (LALI). All of our Global Programs are a long-term investment in community-based leadership in Asia, Africa, and Latin America. Each program consists of up to 15 participants and ranges in length from 2 to 8 weeks. In 2015, after 8 years, we took a break from doing our International Fellowship program and focused on LALI and our work with our partners in Latin America. We also conducted a "reLEAP" advanced training in El Salvador for our graduates from the region. All together, 25 leaders were served in our Global Program in 2015, hailing from Guatemala, Mexico, Haiti, Nicaragua, Honduras, the Dominican Republic and El Salvador. In 2016 we will restart the International Fellowship.

iLEAP's Japan Programs consist of the TOMODACHI Social Innovation in Seattle (SIIS), Social Innovation Forum Japan (SIFJ), Food Innovation for Regional Sustainability in Tohoku (FIRST), and other special short-term programs. Our core Japan programs emerged out of a response to the events of March 11, 2011 in Japan and the need to grow and amplify a new generation of global social leaders in Japan. Our Japan programs have a strong emphasis on applied learning and building connections with partners in the Seattle area. Since 2011 we have trained close to 125 young (18-42 year old) leaders from Japan, and in 2015 we worked with close to 70 participants from Japan. We also conducted two "reLEAP" advanced trainings in Japan for our Japanese graduates.
